For the products which we supply to you, it is relevant to know that they do not contain any forbidden CMR-substances. We have introduced a routine for checking that the material specifications are up to date. Through close contact and communication with our suppliers, we ensure that we receive information at an early stage as to whether hazardous substances are contained. Although the legal requirements in their current version (e.g. RoHS, REACH candidate list) are at the forefront of our enquiries, we also enquire about industry-specific requirements that go beyond the legal requirements in order to be able to initiate substitution requirements as early as possible.

Regarding our own production we can say that our products are manufactured in controlled processes. Our chemical management system ensures that our products were not containing hazardous substances above the legal level.
